

2024 Jamaica Football Federation Club Licensing Support Manual

The Jamaica Football Federation Club Licensing Support Manual has been created to guide clubs in the fulfillment of the JFF Club Licensing Regulations for the 2024-2025 season.

I. General Timetable and Deadlines for the Club Licensing System

The Jamaica Football Federation has established and implemented the Club Licensing System in September 2015. The list below contains an overview of the actions which will be taken by the JFF, as well as the associated deadlines, for the Club Licensing process.

| Deadline | Action |
|-----------------|--|
| 1 July 2024 | Clubs receive notification inviting them to apply for the National Club License via the Concacaf Comet platform. |
| 31 July 2024 | Submission of clubs' license applications and all supporting documentation via the Concacaf Comet platform. |
| 1-8 August 2024 | Review and decision by the JFF First Instance Decision-making body regarding all clubs' license applications. |
| 9 August 2024 | Notification and communication of the first instance decision-making body's licensing decisions to all clubs in writing by the JFF on the Concacaf Comet platform. |
| 14 August 2024 | Written appeals submitted by clubs to the JFF based on decision of the JFF first instance decision-making body. |
| 19 August 2024 | Final decisions by the Appeal instance decision-making body regarding the license applications of club/s submitting appeals. |
| 21 August 2024 | Notification and communication of the Appeal instance decision-making body's licensing decisions to all clubs in writing by the JFF via the Concacaf Comet platform. |
| 23 August 2024 | Submission of all licensing decisions by the JFF to Concacaf. |

II. Responsibilities of the Member Association

In addition to establishing the Club Licensing System, the Jamaica Football Federation has opted to accept additional responsibilities. The actions and associated deadlines for these responsibilities are outlined below.

| Deadline | Action |
|-----------------|---|
| 22-26 July 2024 | Meet with all clubs individually at the beginning of the season to assess the business and sporting plans of the clubs. |
| 26-31 July 2024 | Conduct visit to the stadium, headquarters, and training facilities of all clubs applying for a license. |
| 31 May 2025 | Meet with all clubs at the conclusion of the season to assess the business and sporting plans of the clubs. |

III. Responsibilities of the Club

In order to obtain a Jamaica Football Federation Club License and subsequently become eligible to participate in the domestic club competition of the JFF for 2024-2025 season, the club must meet all Domestic Criteria listed in Section III of the JFF Club Licensing Regulations.

These criteria include the completion of the following four (4) forms, which must be accurately completed and submitted by all clubs as part of their Club License application on the Concacaf Comet platform.

- Club Infrastructure Form
- Club General Form
- Club Finance Form
- Club Youth Development Form

The five (5) tables below indicate all criteria which must be met by the club in order to be granted a license for the 2024-2025 season. The Supporting Documentation indicated must be submitted in the club's license application by the specified deadline on the Concacaf Comet platform.

If the club fails to meet <u>ANY</u> of the Domestic Criteria listed in the tables below, the club will not be granted a license for the 2024-2025 season.

The Regional Criteria listed came into effect as of the 2016-2017 edition of the CONCACAF Champions League.
